



Bushwalking Leadership S.A. Inc. Constitution

July 2000

1. Name

The name of the Incorporated Association shall be Bushwalking Leadership S.A. Incorporated, hereinafter referred to as "The Board".

2. Objects

The Objects of the Board will be:

- 1 To promote bush and mountain walking within South Australia and by the South Australian comlnunity including conducting courses in walking
- 2 To promote best practice in the standards ofwalking leaders
- To conduct courses in leadership for bush and Inountain walking
- 4 To encourage and facilitate walking leaders to pursue accreditation of leadership developed through experience, and
- offer advice and assistance to organizations and individuals on matters relating to bush and mountain walking.

3. Powers

Board

- Acquire, hold, deal with and dispose of, any real or personal property
- 2 Administer any property on trust
- Receive and accept donations of any description whatsoever
- 4 Open and operate accounts with banks or other financial institutions approved by the Board
- 5 Invest finds in approved trustee securities or in any other manner authorized by the Board
- 6 Borrow Inoney on such terms and conditions as may be approved by the Board
- Give such security for the discharge of liabilities incurred by the Association as the Board thinks fit

- 8. Enter into arrangements for the sponsorship of the Board, or the sponsorship or endorselnent by the Board oftheir activities or products
- 9. Raise ftmds by means of commissions or in any other lawful manner
- 10. Expend funds in any manner consistent with the objects of the Board
- 11. Affiliate with any other body, whether incorporated or not, whose objects are consistent with those of the Board on such terms and conditions as may be approved by the Board and
- 12. Do such other lawftll acts or things as may be appropriate to further the objects of the Board.

4. Non Profit Organization

The income and property of the Board howsoever derived shall be applied solely towards the objects of the Board as set out in clause 2 of this Constitution and subject to the provisions of Staff Clause 6 hereof no portion of such incOlne or property shall be paid or transferred directly or indirectly to any member of the Board.

5. Membership

- 1. The Board will consist of:
 - a) An independent Chairperson nOlninated by the Board
 - b) Chairperson and five other melnbersof the Training, Advisory and Assessment (TAA) Panel, elected by that panel
 - c) Not lnore than six other persons coopted by the Board
 - d) An Executive Officer appointed by the Board, who will, with the permission of the Board, be an ex officio melnber of the Board

- 2. All Inelnbers of the Board, with the sole exception of the Executive Officer, will be appointed for a term not exceeding two years but upon expiration of the term for which the member is appointed the member will be eligible for reappointment ifthen qualified. Those members of the Board to retire each year will be determined by the Board which will ensure, as far as possible, that they retire in rotation.
- 3. TI1e Board may suspend ti.emembership of any member for such period as it thinks fit, or may expel any member, on account of conduct which in the opinion of the Board is detrimental to the interests of the Board; provided that no such decision win be taken unless the Board member concerned an opportunity to show cause against the proposed suspension or expulsion; and provided further that Lhe member will have LIte rig.. Itt of appeal to a Meeting of the Board against any decision of the Board to suspend or expel himlher.
- 4. i\ny member of the Board who fails to attend three consecutive Board Meetings without satisfactory explanation will cease to be a Member of the Board.

6. Officers and Staff

- The Officers of the Board win be the Olairperson, Vice-Chairperson, Treasurer and Executive Officer
- The Treasurer and Vice-01airperson win be appointment by the Board from among its members at its first meeting following the end of the financial year of the Board and will hold office until the corresponding meeting of the Board in the next financial year. The Board may also appoint from its members Deputies to act on behalfofthe Treasurer in hislher absence
- The Board may appoint such members of staff, whether paid or unpaid, as it deems necessruy to cany out its functions and Inay determine their conditions or service. The Board Inay delegate any offits powers to such staff melnbers, and
- The Executive Officer will be the public officer of the Association.

7. Proceedings of the Board

- 1 The Board will normally meet monthly and at such other times and place as it may determine
- 2 The quonun for a meeting of the Board will be four Inembers to include the Chairperson or the Vice-Chairperson
- At every meeting of the Board the Olair will be taken by the Olairperson or in hislher absence by the Vice-Chairperson
- Questions arising at any Ineeting will be decided by a majority of votes, and in the event of equality of votes the Chairperson will have a casting vote in addition to a deliberative vote, and
- 5 A Inember of the Board having a pecuniary interest in a proposed contract with the Board Inust disclose that interest to the Board and will not vote with respect to that contract.

8. Committees and Sub-Committees

1. The Board Inay appoint frOln among its melnbers any other cOlnmittee for any special purpose and may add to such committee with or without voting powers for such period as it may think fit, any other person, whether a member of the Board or not, with the work of the Board it considers to be valuable.

9. Minutes

- 1. Minutes of all proceedings of Meetings, of the Board and its COImnittees and sub-committees will be entered in books kept for that purpose and will be signed as a correct record of the Ineeting by the Chairperson of that lneeting or by the Chairperson of the next succeeding meeting BUSHWALKING LEADERSHIP S.A. INC.
- Where minutes have been so entered and signed, then until the contrary is proved the meeting will be deelned to have been duly convened and held, all proceedings of the meeting will be deemed to have been duly convened, all appointments made at the meeting will be deeilled to be valid, and the minutes will be conclusive proofofthe proceedings ofthe meeting, and
- The books containing the minutes of proceedings of any Meeting will be open at reasonable times to the inspection of any lueluber without charge on application to the Executive Officer.

10. The Seal

- The Board will have a C01llluon Seal which will not be used without the express authorization of the Board, and every use of the Seal will be recorded in the Minute Book of the Board
- The affixing of the Seal will be witnessed by the Executive Officer and one other Illelnber of the Board, and
- The Seal will be kept in the custody of the Executive Officer or such other person as the Board Inay frOIU time to time decide.

11. Rules

The Board may make such ndes as it Illay deem necessary frOill tilne to time as to its procedure and for the conduct of the business and affairs of the Board, and for the dispatch of business at its meetings and those of its Committees and subcommittees, provided that such nIles do not contravene any of the provisions of this Constitution.

12. Finance and Accounts

- L The financial year of the Board will be the period of twelve months ending on 30th June each year
- 2. The Board will cause proper accounts to be kept with respect to:
- All smus of Illoney received and expended by the Board and the Illatter in respect ofwhich the receipt or expenditure takes place
- All sales and purchases ofreal and personal property by the Board, and
- The receipts and payments of the Board
- Such accounts win be made up to 30th June each year, and as soon as possible thereafter will be audited by the duly appointed auditor of the Board
- The auditor will be a duly qualified accountant, who will not be a member of the Board
 - 5, The auditor win be appointed at next the the financial year
 - 6. The accounts for the year, including a balance sheet, with the auditor's report thereon, will be laid before the Board at the Meeting after their receipt by the Treasurer or Executive Officer

- Subject to the authority of the Boar~ all cheques, bills of exchange and promissory notes will be signed on behalf of the Board by two Inembers of the Board duly nominated for the purpose, and
- 2 Subject to the control of the Board, the authority of the Board may be exercised on its behalf by the Treasurer with respect to financial Inatters arising in the normal course of conduct of the business of the Board.

13. Amendment of Constitution

- 1. Any proposal for the 31nendment of this Constitution will be submitted to a Meeting of members of the Board and details of such proposed amendment will be set out in the notice calling the meeting.
- 2, The amendment will be approved if a two-thirds tnajority of the Board melnbers vote personally or by proxy in favour ofthe proposal.
- 3. Such attended the will take effect from the date of the Meeting which approved the amendment, or fro In such other date as Inay be determined by the Meeting.

14. Dissolution of Association

- The Board Inay be dissolved at any time by resolution approved by a two-thirds majority of the Board at a Special Meeting convened for the purpose.
- 2 In the event of dissolution of the Board, any surplus assets of the Board will be disposed ofin such manner as may be detennined by the Special Meeting.

15. Interpretation
